Dred Scott's America (in progress)

This narrative history tells the story of the Dred Scott case by following its principal actors from the 1790s, when Scott was born in Southampton Co, Virginia, to the Upper Mississippi River, through the Civil War and beyond. Historians and legal scholars have analyzed the Dred Scott case extensively as a matter of law and politics, but there is no account yet written of those whose lives came together in the case and the worlds they inhabited, encountered, and experienced.
